# Developing a Survey for History Graduate Students

- 10 questions soliciting graduate feedback on how students learned about the programs; the factors that led the students to admit to the history graduate programs; factors about funding; particular interest in a field of study; strengths and weaknesses, etc.
- Feedback is beneficial as we learn from the students' perspective about the History M.A. and Ph.D. program
- Plan to administer the questionnaire in the spring 2024. We anticipate the survey will be most helpful in assessing our History M.A and Ph.D. programs
- Discuss the graduate program feedback to evaluate the future of our programs and thinking about graduate education





# **FLC Deliverables**

Faculty learning community (FLC) participants submit updated syllabi & complete module templates with their planned revisions, assignments, and assessment plans. Feedback is provided prior to implementation.

# **Debriefs & Assessment**

Faculty submit debrief reports on implementation/pedagogical results. Grant-supported graduate student conducts extensive literature review to inform assessment of results.



pre-& post- surveys of climate change learning community faculty participants (10); <u>The focus:</u> New/revised course plans to focus 10%+ of the content on climate change.

revisions in AY 2022-2023. Five of the ten participants (and I) voluntarily conduct pre-& poststudent climate literacy & engagement surveys in their courses.

# **Future Directions**

Results have been published in peerreviewed environmental education journal and conference proceedings. These results will inform future study of professional development and curricular integration of climate change.

# **Assess & Present**

The survey instrument data, debrief reports, and literature (on FLCs, climate literacy, & curricular integration of climate change) are cross-compared and analyzed. Data are then reported at conferences.
