R-word

“You are so retarded,” or, “that’s retarded,” are sayings that are used loosely. It was not seen as “wrong” twenty years ago, but today it has become a very rampant saying. For example, if someone trips, a friend might call them the “R” word, but there is no reason for it. Even if you think people don’t hear you they do, and it is extremely offensive to a large portion of the people.

Do people who use the “R” word constantly, understand the real meaning? Calling someone the “R” word who does not have special needs is careless. Calling someone who has special needs the “R” word is completely de-meaning. There are many appropriate words to use, and the “R” word is not one.
