**Summer recap:** If you haven't been on campus since April, I would like to encourage you to check out the last four monthly CTO Updates as there have been a lot of exciting technology related changes this summer! For example:

- Approximately 50 classrooms received technology upgrades this summer, thus completing an eight year project to convert all of WMU's registrar scheduled general purpose classrooms (over 200 of them) from analog technology (VHS) to digital (Blu-ray). This fall there are ten classrooms on campus that will be testing a new wireless connectivity solution to determine if the solution can be deployed campus-wide! If you happen to be in one of these classrooms, please provide your instructor with feedback. Thanks!
- This summer digital badges were fully integrated into WMU's Elearning environment.
- A brand new lecture capture solution called My Mediasite was installed this summer. It will eventually replace the Techsmith Relay product.
- The campus move to W-Exchange, the new Microsoft Office 365 email system, is 97% complete. The remaining 3% of accounts (approximately 1800) will be migrated during October.



- The Bernhard Center computer lab saw a major remodel this summer and is very very close to opening up its new "Technology Collaboration" space. Please let us know what you think of the newly designed BCC lab. And, if you get a chance please stop by the University Computing Center's computing lab on the second floor and poke your head into the new student-run interdisciplinary maker space!
