#### PROFESSIONAL ACTIVITIES

JUNE, 1980

LLOYD BRAITHWAITE is serving on three state-wide committees: the Michigan Citizens Coalition on Corrections, the Education/Training Task Force, and the Deinstitution-alization Task Force of the Michigan Office of Criminal Justice.

DAVE CHAPLIN was asked by the President of the Latin American Studies Association to chair a three-person task force on "the demand for Latin Americanists for the next 10 to 20 years and the curricular implications of this market." He also serves on the "Committee on the Profession" for CLASP, the Consortium of Latin American Studies Programs. Dave is organizing a panel on the "Sociology of Developing Countries" for the 1980 ASA meetings in New York City. Since early 1979, Dave has been a semi-formal consultant to the ASA's Committee on World Sociology to form a working group on mechanisms for the transnational training of sociologists. Dave has been re-elected departmental chair.

TILMAN COTHRAN was appointed to a four-year term on the Dubois, Johnson, and Frazier Awards Committee of the American Sociological Association. He was also appointed to the Development Committee of the North Central Sociological Association. Tilman is also a member of the Michigan State Committee on Global Education.

PAUL FRIDAY was elected to the Scientific Commission of the International Society for Criminology in Paris. He has previously served for four years as the U.S. delegate to the Society. Paul was also appointed to chair, International Liaison, American Society for Criminology. He also served as chair of a session on "Comparative Corrections" at the November, 1979 ASC meeting in Philadelphia. In addition, Paul was appointed to the Michigan Criminal Justice Advisory Commission. He serves on the State Task Force on Crime Prevention. He continues to serve as President of the International Sociological Association section on Deviance and Social Control and is currently co-ordinating a conference on Crime and Development to be held in Ibadan, Nigeria in July, 1980.

RON KRAMER organized and chaired a session on "Corporate and Government Lawlessness" at the Academy of Criminal Justice Sciences meetings in Oklahoma City. He also organized and chaired a session on "Corporate and White Collar Crime" for the North Central Sociological Association meetings in Dayton.

BOB LEIGHNINGER has become editor of the <u>Journal of Sociology and Social Work</u>. Its editorial office is jointly sponsored by the Department of Sociology and the School of Social Work. He is also organizer for a symposium on the language of science at the June meeting of the <u>American Association for the Advancement of Science</u> - Pacific Division, Davis, California.

JIM PETERSEN was elected Vice President for Research of AVAS, the <u>Association of Voluntary Action Scholars</u>. Jim also served as Program Chair of the 1979 AVAS convention in San Antonio where he chaired a session on "Voluntary Associations."

ELLEN ROBIN has been elected vice-chair of the Gerontology section of the Michigan Academy of Science, Arts and Letters. Ellen presided over a session on Higher Education and Gerontology at the 1980 Michigan Academy of Science, Arts, and Letters meeting and discussed Gerontology Programs at Western.

TILMAN COTHRAN was appointed visiting scholar in the spring quarter, 1979 at the Department of Sociology, University of Chicago. While there he studied gerontology with Bernice Neugarten. In 1979 Tilman visited several universities in Hong Kong, Thailand, and Korea. During the year he also read proposals for the Division of International Education of the Office of Education in Washington, D.C.

#### Books

The second edition of RUTH AND EDSEL ERICKSON's Children with Reading Problems:

A Guidebook for Parents has been published.

PAUL FRIDAY has published <u>International Assessment of Adult Probation</u>, National Institute of Law Enforcement, Washington, D.C.: U.S. Government Printing Office, September, 1979.

The fifth edition (1980) of PAUL HORTON AND CHESTER HUNT's <u>Sociology</u> has been published by McGraw-Hill, together with a Study Guide, Teacher's Manual and Test File. A Portuguese language edition of <u>Sociology</u> is being published by Editora McGraw-Hill do Brazil. A new Spanish translation is also in preparation and will appear soon.

JERRY MARKLE AND JIM PETERSEN are editors of <u>Politics</u>, <u>Science and Cancer: The Laetrile Phenomenon</u> (Westview), 1980. This is a volume in the American Association for the Advancement of Science Selected Symposia Series and is based on the symposium they organized for AAAS on perspectives on the Laetrile controversy.

TOM VAN VALEY has co-authored (with C. Kaplan) Census '80: Continuing the Factfinder Tradition, Bureau of the Census, U.S. GPO, January, 1980. Writing this book was one of Tom's responsibilities when he spent two months last summer as a resident consultant to the U.S. Bureau of the Census, Data User Services Division. The book has been used in the Bureau's Experimental Student Internship Program throughout the country.

MORTY WAGENFELD AND RUBY IVENS along with James Flax and Robert Weiss produced the National Institute of Mental Health publication (NIMH) Mental Health and Rural America: An Overview and Annotated Bibliography, U.S. GPO, Washington, D.C., 1979.

From over 2000 books reviewed by the American School Board Journal, Child Abuse and Neglect by EDSEL ERICKSON and AL McEVOY was selected as one of only 40 deserving meritorious recognition. Edsel was editor for another book Identifying Children with Special Problems by Joiner which also was one in the top 40 recognized as meritorious. He is also contributing review editor (free lance, Prentice-Hall) for the forthcoming revised book Reaching Out by David Johnson. The first edition sold 17 printings and is considered one of the most successful of Prentice-Hall books.

#### Grants and Research Projects

JERRY MARKLE received a Faculty Research Fund Grant and Fellowship to study "Determinants of Cigarette Smoking: A Multivariate Analysis."

RON KRAMER has been awarded a WMU Faculty Research Fund Fellowship for the Spring Term, 1980 to continue his research on corporate violence (the case study of the Ford Pinto Affair).

The actual coding of the police crime reports and arrest reports is being done by students Todd Burr, Sharon Caldwell, Mary Graham, Janis Loomis, Leslie McCracken, Mike O'Kelley, Mary Osborn, Laura Sokolsky, Julie Sumpter, Terry Whaley, and Shelly Wood. Upon completion the report will be submitted to the local Criminal Justice Committee for use in planning the prevention and control of forcible rape.

He has been named to the board of directors of the Riverwood Community Health Center, and has conducted preservice personnel evaluations for several police and sheriff's departments in the area.

#### Very Special Events

1979-80 has been a year of special university honors for several members of the department.

CHET HUNT was named one of this year's three Distinguished Faculty Scholars. This involves an honorarium of \$1,500 (thoughtfully forwarded to him in the Philippines) and a public lecture ("A Philippine Saga") and a plaque from President Bernhard. (As luck -- or Chet -- would have it, the tornado struck shortly after Chet received his plaque and he had barely begun his talk. After the audience returned from hiding, Chet carried on, grateful that we had been saved from "too dry a speech.")

## Very Special Events (Cont.)

The press release on Chet's award read as follows:

Selection criteria for the Distinguished Faculty Scholar Award include outstanding professional achievement in artistic, historical, literary, philosophical, scientific or technical areas; wide recognition by the academic community beyond WMU; and a substantial part of the achievement must have been accomplished while at WMU.

Hunt, who joined the Western faculty in 1948, served as acting head of the Department of Sociology at the University of the Philippines from 1952 to 1954 under a Fulbright grant and is credited with revitalizing that department in the post-World War II period. He founded and became the first editor of the Philippine Sociological Review at that time.

Under a 1961-62 Fulbright and Institute of Regional Studies grant, he taught at Silliman University in the Philippines and International Christian University in Tokyo, Japan. In 1975 he served as a Fulbright lecturer at Central Philippine University, where he recently completed an academic year of research.

Hunt has written or co-authored more than 50 articles published in American and foreign periodicals as well as two books; he co-authored two others and edited another.

Following this award, and also in his honor, Western sponsored the 15th meeting of the Philippine Studies Association whose first meeting was also held here.

Our other very special awardee is DUANE ROBERTS (B.A. in Sociology at WMU in 1950). Duane was given an honorary doctorate of public service for his many (and continuing) years of service on behalf of racial equality in the Kalamazoo Public Schools and related civil rights issues. As the Kalamazoo Gazette noted in its Sunday editorial (April 20, 1960), "Since the late 1940s, whenever there has been a local issue that involves racial justice and human relations, Roberts has been at the forefront of the action ... setbacks never embittered Roberts or caused him to lose faith in the system — a system he fought for in World War II as a member of a segregated Army Air Force unit."

During his induction into AKD this year, he thanked the department for giving him the self-confidence and know-how to become an active participant in local civic action.

## A Special Event

Early in June we were very pleased to be visited by DR. JOSEPHUS C. VERHOEVEN, Professor of Sociology at the University of Leuven, Belgium. He has been spending the year at the University of California, Santa Barbara, on a grant from the American Council of Learned Societies to study Symbolic Interactionism. Part of his project included interviewing the major scholars in this field, hence his visit to Western to talk with JERRY MANIS who, while officially retired, is very much a continuing member of the department.
