PROFESSIONAL ACTIVITIES

TILMAN COTHPAN was appointed chair of the DuBois-Johnson-Frazier Award Committee by the American Sociological Association for 1981-83.

RON KRAMER has been asked to serve as chair of the Public Policy Committee of the North Central Sociological Association. His two-year term began in May, 1982 at the annual meeting in Detroit.

MORT WAGENFELD has been appointed secretary of the Mental Health Policy Section of the National Association for Public Health Policy.

PAUL FRIDAY continued as President of the Deviance and Social Control section of the <u>International Sociological Association</u>. He also serves on the ISA's Research Council. Paul is also on the Scientific Commission and the Executive Council of the <u>International Society of Criminology</u> and was appointed to the <u>American Society of Criminology</u>'s Publications Board in 1982.

LLOYD BRAITHWAITE was elected President of the Michigan <u>Criminal Justice Educators Association</u> at the July, 1981 Lansing meeting. Lloyd was appointed an Editorial Reviewer for <u>Corrections Today</u>, the official publication of the American Correctional Association.

FUNDED PROGRAMS DURING 1981-82

PAUL FRIDAY received a Faculty Research Award on "Congruities in Perceptions of Justice." Paul also received a \$10,000 grant from the German Academic Exchange to support Western Michigan University students traveling to Mönchengladbach, West Germany for the Fifth International Seminar in Comparative Criminal Justice. Paul's Milwood delinquency prevention project received \$140,000 in continuation funding from the Office of Juvenile Justice and Delinquency Prevention. Third year funding for \$99,000 has just been confirmed (see page 9).

In December, 1981 RON KRAMER was awarded a Faculty Research Fund Fellowship (\$3,000) and Grant (\$1,500) for a research proposal titled, "Understanding Prosecutorial Discretion: The Decision to Charge." SUSAN CARINGELLA-MAC DONALD assisted in the writing of the proposal and will serve as Co-Director of the project.

JERRY MARKLE and STAN ROBIN won a <u>National Endowment for the Humanities</u> Award, 1982 Summer Fellowship to develop a volume in <u>Sociology of Science</u> on <u>Recombinant DNA</u> and <u>Genetic Engineering</u>. Jerry also is a Co-Principal Investigator with Daryle Chubin (Georgia Tech) in a <u>National Science Foundation</u> grant on "Consensus Development: Exploring the Negotiation of Biomedical Disputes."

BOB LEIGHNINGER (adjunct associate) is the Center for Human Services Project Coordinator for a Michigan Department of Mental Health grant of \$132,000 to study Work and Day Activity Centers for Developmentally Disabled Adults.

STAN ROBIN and TOM VAN VALEY were the principal investigators for the LIFT (Loan Improvement Funding Today) Foundation's project on "Housing Needs." This foundation has been one of the prime movers of local public housing since the 1960s. One of the earliest community research projects carried out by our staff was on several public housing referenda during the early 1960s which received apparently massive "establishment" support yet were repeatedly voted down.

SUBHASH SONNAD conducted research on the introduction, use and impact of the THINKABOUT instructional television series, with James R. Sanders (Evaluation Center).

STAN ROBIN and JAY BRODBAR conducted research on Emergency Medical Transportation for the Borgess Medical Center, the department's first hospital-funded project. It was followed by another Borgess project headed by Tom VanValey on their Family Birthing Center.

JAMES PETERSEN and Dan Farrell were awarded funds for the development of an educational module on "whistle-blowing" to be used in the education of engineers. This work is funded by the Center for the Study of Ethics in the Professions -- Exxon Grant Program.

UNIVERSITY AND COMMUNITY ACTIVITIES

1981-82 was a heavy year for reaccreditations. In the North Central review, Sociology was ranked among the top five departments in Arts and Sciences at WMU. In the School of Social Work's reaccreditation, their requirement of our special research methods course was commended as "unique" and worthy of being written up in the <u>Journal of Social Work Education</u> and presented at this association's annual conference.

MORT WAGENFELD has been elected chair of the Kalamazoo County Health Department Board.

STAN ROBIN is the secretary of the Child Guidance Council of Kalamazoo.

This year saw the full-fledged development of an Academic Assistance Program under LEW WALKER'S direction. It finds student tutors for students needing extra help in our courses.

ROSAMOND ROBBERT (a doctoral student) was reappointed to the Financial Aid Council for the 1981-1982 academic year.

TILMAN COTHRAN was a panelist in February, 1982 for the Black American Studies Program. The subject was "Racism in America."

RON KRAMER gave the following local lectures: participated in a panel discussion of "New Trends and Issues in Criminology, Sociology TGIF; participated in a panel discussion on "Crime in America," Oaklands Discussion, Honors College; participated in a panel discussion of "Paradigms in Sociology," TGIF symposium, October, 1981 and a lecture on "The Political Economy of Cultural Revolution" presented at a panel discussion on Daniel Yankelovich's New Rules in American Life, Kanley Chapel, May, 1981.

The Criminal Justice Student Association (CJSA) under RON KRAMER's stewardship had a very active year of speakers and field trips, climaxed by losing a basketball game with the faculty team. Field trips included the crime lab in Holland, the juvenile home and court, and the Ionia Reformatory.

PAUL FRIDAY led a group of WMU and Northern Michigan students, plus local professionals to Germany for the IV International Mönchengladbach Seminar on comparative criminal justice. The expenses for travel and living in Germany were covered largely by a German grant of \$10,000. Dr. GERD KIRCHHOFF, adjunct professor at WMU and Professor of Criminology at the Fachhochschule Niederrhein, hosted the group for a three-week study travel tour. The next seminar is planned for 1984. The WMU group included: Michelle Kampf, a Manchester senior; Bryant Thomas, a Pontiac senior; Julie Draper, a Grosse Pointe senior; Maratha Hagerty, a Kalamazoo senior; Kirk Kaiser, a Nazareth College CJ student; John Andrews, MPA program and Superintendent of Waterloo Corrections Facility; Peggy Chance, a new sociology graduate student; Sr. Beth Butler, Siena Heights College; and Judge Donald James, Kalamazoo District Court.

MILT BRAWER is corresponding secretary for the Faculty Senate and is a member of the Executive Board. He has been a member for the past three years. Milt conducted the following institutional research at Western: Management Department evaluation for topics in introductory statistics courses; Student Services Council study on student needs for informal work/lounge areas in classroom buildings. He also is a member of the AAUP Associate Council, the Student Services Council, the Western Michigan University Ad Hoc Committee to Review Priorities Project and the Ad Hoc Committee on Capping Enrollments. He is also a member of the University Student Retention Committee.

CHARLOTTE COULSTON (doctoral student) and LINDA ROUSE are continuing in the capacity of research consultants to the Kalamazoo Domestic Assault Program. Charlotte recently completed a codebook which will enable the KDAP staff to convert client information questionnaires which the Michigan Department of Social Services requires them to gather to "data" for various agency level uses. Statistical tables are expected to be forthcoming. Charlotte attended the spring meeting of the Society of Women Sociologists in East Lansing and learned about the potential liabilities of the mentor-protege relationship, as well as its touted advantages for graduate students.

A number of faculty tape-recorded talks for News Call for distribution to 20-40 radio stations throughout Western Michigan. MILT BRAWER spoke on "Loneliness in America," MORT WAGENFELD on "The Effects of Social Ties On Our Lives," PAUL FRIDAY on "Crime and Unemployment," LLOYD BRAITHWAITE on "Prison Overcrowding" and TOM VAN VALEY on "The 1980 Census." PAUL FRIDAY also taped a program on Poland (which he visited just prior to the imposition of martial law) with WKZO-TV.

ROSAMOND ROBBERT presented two workshops on "Senile Dementia" in July, 1981, two on "Ageism" in February 1982 and one on the same topic in June 1982. All the workshops were held at Kellogg Community College and funded by the Kendall Foundation. Rosamond also organized and presented four workshops for the Southcentral Michigan Commission on Aging on "Knowledge and Skills for Working with the Elderly" in June 1981. She presented two similar workshops for the SMCA in May and June, 1982.

The Tenth Annual Great Smokes Backpacking/Camping Trip hosted by the Sociology Department and the Honors College was well attended this year. MILT BRAWER (Director), SUBHASH SONNAD and 25 students enjoyed a week of hiking, swimming, and fishing. The week concluded with a visit to the World's Fair in Knoxville, Tennessee.

Pilot Milwood school project gets good marks for kids' attendance

A unique pilot program designed C. Friday, professor of sociology to foster a school climate in which all students can be successful is believed to have played a major role in reducing the number of student suspensions from 173 in September and October 1980 to 27 in the same period in 1981 at Milwood Junior High School in Kalamazoo.

Called "The Milwood Project," the program is being financed by a two-year, \$268,315 grant from the office of Juvenile Justice and Delinquincy Prevention in Washington, D.C.

A joint effort between Western Michigan University and the Kalamazoo Public schools, the prograin "was spawned by a concern of the Kalamazoo County Criminal Justice Commission that an increasing portion of community crime was being committed by school-age youths," said Dr. Paul

(Continued from Page A-1) is also what the parents want keeping their youngsters in school."

An alternative classroom concept is also being tried, Friday noted. Sixty students in three classes are involved in intensive interaction with teachers, counselors and other students, he said, all aimed at fostering good behavior.

Steeby said these classes contain a cross section of students of varying backgrounds, including students with good conduct records and some with behavior program at WMU.

Friday developed the program with H. Preston Elrod, a doctoral student at WMU and project director, and Milwood Junior High staff. Poor school performance, project staff members said, is a major factor associated with delinquincy.

One of 11 programs receiving federal funds in the United States. Friday said the Milwood Project is the only project in the nation "that does not treat the individual but rather is aimed at changing the social conditions leading to delinqueny."

"A certain number of our students who were not doing well in school now are finding some success since the project was begun," said Milwood Principal Dale E. Steeby.

problems.

The group puts pressure on individual class members to maintain good attendance, Steeby said, do their class work and stay out of trouble. Their reward at the end of the semester may be an interesting field trip or some other outing that class members do not want jeopardized by the misbehavior of a few individuals, he added.

The classes have developed the attitude, Steeby said, that "we as a group will maintain attendance and good behavior goals by individuals."

Friday credits a special homeand director of the criminal justice school liaison worker hired by the Kalamazoo Schools with the grant money for making success stories of some students. Steeby said one student who complained he was always tardy because he had no alarm clock was given a clock by the liaison worker. The student's tardy record, Steeby said, improved considerably.

> In other cases, Friday said, the liasion worker has brought students to school and driven parents to meetings intended to outline goals of the project, bringing the parents into active participation in events at the school.

> "A major aim of this project is to keep students in school rather than perhaps roaming the streets while on suspension," Steeby said. 'An in-house suspension room has worked quite well to that end and

> Elrod; a doctoral student in psychology at WMU, is stationed at the school.

> "The Milwood project is not geared just to making the school experience better for students with behavioral problems," Elrod said, "but also is designed to uplift. the education of behaving and productive students whose learning may be obstructed by students: who disrupt the classroom."

Elrod noted that the Milwood' Project allows the public schools to do innovative things that otherwise could not be done because of austere budgets.

One of the most visible departmental activities in the local community was the Milwood project. It has been featured in at least half a dozen Gazette articles this past year starting with the front page piece reproduced here. National wire service pick-ups have resulted in requests for assistance and advice from half a dozen places from Florida to California.

Another important part of the project, Steeby said, are group meetings with parents in their homes to explain the project.

"We have conducted nine such sessions of taking the school to the parents who now have or will have students at Milwood," Steeby said.

Friday believes the project will demonstrate sufficient academic and behavioral success that the Kalamazoo Schools will incorporate part of it into a program at other schools in the system. That was an original intent of the federal grant, Friday said, adding that the grant may be extended another year.
