# **Long Term Care Data**

Michigan's Long-Term Care data collection recently underwent a transition as MDHHS enhanced its data collection process to improve accuracy, timeliness, and to align with new guidance from the federal Center for Medicare & Medicaid Services.

Additional nursing facility data will be available once the it has been appropriately validated.

In the reporting period between June 2, 2020 – June 9, 2020, 98 percent of skilled nursing facilities (SNFs) in Michigan reported data to the Michigan Department of Health and Human Services. Facilities that have completed partial reports are included in this figure. Data will be updated daily, Monday- Friday.

As of June 9, the data below represents a cumulative total of COVID-19 resident cases reported by SNFs in Michigan since January 1, 2020. Facilities that did not report data are listed as "--." Case numbers are provisional and may change as facilities correct or add data. **The cumulative data under the new reporting system includes cases from January 1, 2020 through June 9, 2020.** 

This information does not replace a thoughtful conversation with facility staff about their current infection control practices and mitigation strategies. Questions that families might ask a care facility include:

What are you doing currently to protect residents from COVID-19? What precautions do you take when you do identify a person who is symptomatic of COVID-19? How are families kept apprised of changes related to your infection control policies?

In addition, residents and family members should understand that the presence of COVID-19 at a facility is no way an indicator of a facility that isn't following proper procedures. Families should always feel free to ask questions of the facility where their loved one resides, and if not satisfied, contact their local ombudsman.

**Note:** Some facilities have dedicated space to appropriately isolate and care for residents with COVID-19 and they may also be accepting individuals with COVID-19 that require nursing facility type care from the hospital. Additionally, some facilities are actively performing regular testing on all staff and residents, so counts may fluctuate as pending results become available.
