Changes have recently been made to the clinical variables shared on the MDHHS website. These changes were made to align with the new reporting requirements from the federal government. To better accommodate all users of this data, MDHHS is expanding the data provided from the previous clinical variables section to the information described in the new clinical variables section. Data users should carefully consider which variables meet their current or ongoing needs for information.

Previous Clinical Variables:

- # of ED Discharges The number of patients discharged home (or equivalent) from ED with suspected or confirmed COVID-19 in past 24 hours. INCLUDE hospital urgent care and ED drive through.
- # in Critical Care The CURRENT number of patients in critical care units with suspected or confirmed COVID-19. INCLUDE non-critical care areas being used for surge critical care. DO NOT INCLUDE ED boarding/overflow (patients currently admitted and awaiting bed).
- # on Ventilators The CURRENT number of patients receiving mechanical ventilation with suspected or confirmed COVID-19. DO NOT INCLUDE ED boarding/overflow (patients currently admitted and awaiting bed) and surge critical care areas.
- # of Inpatients The total number of positive tests for COVID-19 among admitted patients.

New Clinical Variables:

Previous Day's COVID-19-related ED Visits (Enter the total number of ED visits who were seen on the previous calendar day who had a visit related to COVID-19 (meets suspected or confirmed definition or presents for COVID diagnostic testing – do not count patients who present for pre-procedure screening).)

Total ICU adult suspected or confirmed positive COVID patients (Patients currently hospitalized in an adult ICU bed who have suspected or laboratory-confirmed COVID-19.)

Hospitalized ICU adult confirmed-positive COVID patients (same as above, laboratory confirmed only)

Hospitalized and ventilated COVID patients (Patients currently hospitalized in an adult, pediatric or neonatal inpatient bed who have suspected or laboratory-confirmed COVID-19 and are on a mechanical ventilator (as defined in 7 above).)

Total hospitalized adult suspected or confirmed positive COVID patients (Patients currently hospitalized in an adult inpatient bed who have laboratory-confirmed or suspected COVID-19. Include those in observation beds.)

Hospitalized adult confirmed-positive COVID patients (same as above, laboratory confirmed only)

Total hospitalized pediatric suspected or confirmed positive COVID patients (Patients currently hospitalized in a pediatric inpatient bed, including NICU, newborn, and nursery, who are suspected or laboratory-confirmed-positive for COVID-19. Include those in observation beds.)

Hospitalized pediatric confirmed-positive COVID patients (Patients currently hospitalized in a pediatric inpatient bed, including NICU, newborn, and nursery, who have laboratory-confirmed COVID-19. Include those in observation beds.)

Non-system hospitals are identified as individual hospitals. The data reflects the status in health systems and hospitals 48 hours prior to the time that the data was posted to this website. This information has been compiled by the Michigan Health & Hospital Association (MHA) on behalf of the Michigan Department of Health & Human Services (MDHHS). The data is from the state of Michigan's EMResource data system. Hospitals are required to enter data into EMResource. The data reflects the status in the hospital or health system from the previous 48 hour riod. General Information: Tableau Dashboard of Health System/Hospital Data

DATA DICTIONARY:

PPE Days on Hand - This is a calculation based on a number of factors including the amount of PPE, the number of COVID-19 patients, beds, industry standard usage and conservation techniques.

COVID-19 Patients – Confirmed positive patients, as well as patients who are currently pending and under investigation (PUI). This includes COVID-19 patients in the ICU.

COVID-19 Patients in ICU - Confirmed postive patients and suspected patients in intensive care unit (ICU).

Bed Occupancy - The percentage of staffed inpatient beds occupied by any patient regardless of COVID-19 status. This includes surge or overlow beds.

Patient Census - Patient census for all health systems/hospitals in Michigan

PPE - Personal protective equipment status for all health systems/hospitals in Michigan
