Long Term Care Data

In an effort to more closely align with federal data collection efforts, effective October 21, 2020, MDHHS transitioned Skilled Nursing Facility (SNF) reporting from daily to weekly on the [Michigan.gov/Coronavirus](https://www.michigan.gov/Coronavirus) website. In addition to the shift to weekly reporting, MDHHS began publishing additional data fields as well as expanding public reporting to include Adult Foster Care (AFC) and Home for the Aged (HFA) facilities with bed capacity of 13 or greater on November 2, 2020. Updated data for all reporting facilities is posted each Monday.

As of December 22, the data below represents a cumulative total of confirmed COVID-19 resident cases, cumulative total of suspected and confirmed resident deaths, cumulative total of confirmed COVID-19 staff cases, and cumulative total of suspected and confirmed staff deaths reported by long-term care facilities in Michigan since January 1, 2020. Case numbers are provisional and may change as facilities correct or add data. **The cumulative data under the new reporting system includes cases from January 1, 2020 through December 22, 2020.**

The onboarding process for licensed AFC and HFA facilities to current reporting requirements and survey platform occurs in two discrete phases; Initial Registration and Weekly Reporting.

Previous releases of the Initial Registration Survey were completed once weekly beginning October 28. Historical cumulative COVID-19 case and death information is confirmed by facilities during the Initial Survey process. New case/death reporting for newly registered facilities begins the week following registration. Therefore, the facilities who just completed registration on December 23rd will only have historical data displayed.

The next opportunity for AFC and HFA facilities to complete the Initial Registration survey in order to begin weekly reporting is December 30, 2020.

Data Validation Process

Ensuring accurate and timely reporting from nursing facilities is a priority for the State of Michigan. The data is critical to guide state efforts and ensure sufficient support is provided where it is needed most, as well as to allow transparency for residents and families. MDHHS began collecting the data on April 23, 2020 and revised the reporting process to align with CDC/CMS requirements on May 22.

To address challenges in SNF reporting, MDHHS initiated a targeted campaign to validate and improve the accuracy of key data fields, clarify state and federal reporting expectations, verify facility staff access to the required systems, and address facilities' questions. The campaign improved adherence to reporting standards and led many facilities to correct their reported data in EMResource.

As MDHHS implements the expansion of public reporting to include HFA and AFC data, there will be focused effort to bring these facilities into compliance and ensure data accuracy.

This information does not replace a thoughtful conversation with facility staff about their current infection control practices and mitigation strategies. Questions that families might ask a care facility include:

- What are you doing currently to protect residents from COVID-19?
- What precautions do you take when you do identify a person who is symptomatic of COVID-19?
- How are families kept apprised of changes related to your infection control policies?

In addition, residents and family members should understand that the presence of COVID-19 at a facility is not alone an indicator that a facility isn't following proper procedures. Families should always feel free to ask questions of the facility where their loved one resides, and if not satisfied, contact their local ombudsman.

Skilled Nursing Facilities are facilities licensed to provide organized nursing care and medical treatment to 7 or more unrelated individuals suffering or recovering from illness, injury, or infirmity. This data set includes all licensed nursing facilities with the exception of hospice residences licensed as nursing homes.

Adult Foster Care Facilities and **Homes for the Aged** provide care to persons not needing the 24 hour nursing care found in nursing facilities, yet need monitoring and assistance with activities of daily living.

- **Adult Foster Care** (AFC) homes are residential settings that provide 24-hour personal care, protection, and supervision for individuals who are developmentally disabled, mentally ill, physically handicapped or aged who cannot live alone but who do not need continuous nursing care. This data set includes all AFCs licensed to care for 13 or more individuals.
- **A Home for the Aged** (HFA) provides 24 hour room, board, and supervised personal care to unrelated individuals 55 years of age or older. This data set includes all licensed HFAs.

Note: Some facilities have dedicated space to appropriately isolate and care for residents with COVID-19 and they may also be accepting individuals with COVID-19 that require nursing facility type care from the hospital. Additionally, some facilities are actively performing regular testing on all staff and residents, so counts may fluctuate as pending results become available.
