WESTERN MICHIGAN UNIVERSITY BOARD OF TRUSTEES

REGULAR MEETING

April 24, 1981

The regular meeting of the Western Michigan University Board of Trustees was held on April 24, 1981 in the Board of Trustees Room of the University Student Center.

The meeting was called to order by Chairman Maury E. Parfet at 9:30 a.m.

Trustees present: Adams, Caine, Edwards, Johnson, Kemp, Parfet and President Bernhard (ex officio).

Also present: Mr. Brinn, Vice President Coyne, Dr. Denenfeld, Vice President Ehrle, Dr. Ethridge, Mr. Gagie, Vice President Hannah, Mr. Matthews, Mr. Smythe, Vice President Wetnight, Dr. Page-Robin, Mr. Stoddard and Dean Jones (Deans' Council Representative).

Acceptance of the Agenda. Following a motion by Trustee Caine, supported by Trustee Adams, the Board of Trustees approved the agenda for the meeting as presented.

Minutes. On a motion by Trustee Kemp, supported by Trustee Johnson, the minutes of the March 20, 1981 regular meeting were approved as distributed.

Correspondence. Dr. Ethridge indicated that communications had been received from Jack H. Roach, President, Local #1668, AFSCME; Stephen Ledoux, graduate student; James E. Walker; Edward W. Harkenrider, Director, Student Financial Aid and Scholarships; and Carl Levin, United States Senate.

President's Remarks. In his prepared remarks (on file in the Secretary's Office), President Bernhard highlighted the following: the best possible recommendation by the North Central Association for continued accreditation for Western for ten years, with no stipulations, and the fine work of Dr. A. L. (Mike) Sebaly who coordinated the accreditation self-study (Chairman Parfet also thanked Dr. Bernhard for his efforts in making the North Central visitation such a success); the awarding of the prestigious John Simon Guggenheim Fellowship Awards to Stuart Dybek and Ramon Zupko; the appointment of Stephanie and George Demetrakopoulos, Carol and Howard Dooley, Ruth and Robert Shafer, and Mildred and Michael Pritchard to the Associates program of the Danforth Foundation; the selection of Dr. George G. Mallinson to receive the Distinguished Service Award; Dr. John E. Sandberg's appointment to serve a one-week assignment as a scholar-diplomat with the U. S. State Department in Washington, D.C.; Dr. Phillip T. Larsen's presence at the launching and landing of the space shuttle, Columbia, by invitation of the National Aeronautics and Space Administration; Dr. Courtney P. Stromsta's trip to Cairo, Egypt, to present seminars in speech pathology at Ainshams University; the awarding of National Endowment for the Arts and Michigan Council of the Arts grants to Curtis Curtis-Smith; the giving of the Michigan State Medical Society's Presidential Award to Jack D. Jones for his work in athletic medicine; the publication of new books by Western faculty -- The Analysis of Covariance and Alternatives by Dr. Bradley E. Huitema, the second edition of Creative Drama for the Classroom

Teacher by Drs. Ruth Beall Heinig and Lyda Stillwell, The Air and Sea Lanes of the North Atlantic: Their Security in the 1980's by Dr. Sherwood S. Cordier, and the seventh edition of Sociology of Social Problems by emeritus professor Paul Horton; Laura V. Shaw's 90th birthday celebration at the University Theatre's production of "A Midsummer Night's Dream;" the co-winners of the Woman of the Year Award, Virginia E. Norton and Betty L. Fouch, as announced by the Commission on the Status of Women; the 16th International Congress on Medieval Studies to be held on campus May 7-10; the 30th anniversary of our FM radio station, WMUK, under the direction of station manager Garrard D. Macleod; the granting of the Sprout Award to Dr. Kenneth Dahlberg for his book, Beyond the Green Revolution: The Ecology and Politics of Global Agricultural Development; the first annual science night banquet sponsored by the Science for Minority Citizens Center of Southwestern Michigan and Western's College of Arts and Sciences, with LeRoi R. Ray as chair of the program's advisory council; the election of Martin R. "Joe" Gagie to one-year terms on the Board of Directors of the Kalamazoo County Chamber of Commerce and the Greater Kalamazoo United Way; the fine work of Vice President Tom Coyne over the past six years for his leadership in the United Way campus campaign; the selection of Debbe Gregory, senior pre-law student, as a Kalamazoo community ambassador; the 1980 Annual Report of the University Placement Services as prepared by Dr. Chester Arnold and his staff; the election of Mark Siljander, Western alumnus, as fourth district Congressman; and the winning of the decathlon event in the Drake relays by Michael Bishop, junior student from Saginaw. Trustee Caine thanked Dr. Bernhard for his fine report.

Dr. Bernhard also reported the death of Fred E. Gaissert, sophomore student, from Walled Lake.

Dr. Ehrle asked that the Board extend its congratulations to Roger Bennett for his outstanding service as president of the Faculty Senate, and Dr. Ehrle also introduced the new president of the Senate, Dr. Ellen Page-Robin.

Academic Personnel Report. On a motion by Trustee Adams, supported by Trustee Johnson, the Board of Trustees approved the report as presented by Dr. Ehrle and endorsed by the Academic Affairs Committee. Chairman Parfet observed that there were no minority persons on the tenure list. She reaffirmed the Board's commitment to affirmative action and expressed the hope that in the future these reports would be reflective of the University's affirmative action policy.
